Executive Director, Nevada Positive Behavior Interventions and Supports Technical Assistance Center (Nevada PBIS), Nevada Center for Excellence in Disabilities, University of Nevada, Reno. July 2011 – present.

Create, build, and install behavioral health systems using an organizational behavior management approach in school districts and state agencies. In this role, I write, secure, manage, and oversee various state and federal grants, with combined budgets totaling over \$2 million per year. Serve on and chair multiple community-based committees in state agencies such as Department of Education and Department of Health and Human Services and contribute to policy revision and implementation. Work collaboratively with high-level internal and external stakeholders to grow and expand the vision and mission of the organization. Supervise the daily activities, inputs, and outputs of over 25 managers and trainers that serve approximately 200 organizations and impact over 175,000 individuals. Engage in strategic planning and evaluation efforts related to all projects of Nevada PBIS.
